

RESOLUTION NO. 2026-06

A RESOLUTION CANCELING THE ELECTION ON MARCH 24, 2026 FOR ONE MEMBER OF THE BOARD OF SUPERVISORS OF HERONS GLEN RECREATION DISTRICT; ACCEPTING THE QUALIFICATION OF CANDIDATE KAREN MARS; DECLARING CANDIDATE KAREN MARS ELECTED TO THE POSITION OF SUPERVISOR FOR A TERM OF THREE YEARS COMMENCING APRIL 1, 2026, AND, CANCELING THE MEET THE CANDIDATES MEETING.

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE HERONS GLEN RECREATION DISTRICT:

SECTION 1. AUTHORITY FOR THIS RESOLUTION. The Board is authorized to adopt this Resolution under the authority granted by the provisions of Chapter 418, Part II, Florida Statutes, as amended, Ordinance No. 98-08 adopted by Lee County, Florida on April 28, 1998, as amended, and other applicable provisions of Florida law.

SECTION 2. FINDINGS.

- A. Pursuant to Resolution 2026-01 adopted January 26, 2026, the Herons Glen Recreation District called for its regular election to elect ONE (1) member of the Board of Supervisors, for a three (3) year term beginning April 1, 2026, and setting qualifying for said positions to be opened on February 2, 2026 and closed on February 13, 2026 at 5:00 P.M.
- B. The election and qualifying process were publicly declared at the Districts general meeting and Notices of the same have been posted and published as required by law.
- C. The time for qualifying has expired.
- D. Only one (1) candidate, Karen Mars, has qualified to run for the ONE open position on the Board of Supervisors.

SECTION 3. CANCEL ELECTION AND DECLARE WINNER. There being only one qualified candidate and only one open positions on the Board of Supervisors, it is hereby determined and declared that the election scheduled and noticed for March 24, 2026 is not needed, should be and is, canceled and candidate Karen Mars should be, and is, declared the winner of the said election, to continue her in the capacity of Supervisor on the Board of Supervisors of the District for a three year term beginning April 1, 2026.

SECTION 4. The “Meet the Candidates” Board Meeting previously scheduled for March 5, 2026 at 5:00 p.m., is hereby canceled.

SECTION 5. EFFECTIVE DATE. This Resolution shall be effective immediately upon its adoption.
